CEO'S Review



Team

Each year in this report, it is my privilege to look back at our achievements and share some highlights.

COVID-19 remained a constant in our lives with ACHA adapting to legislative changes during 2022 and transitioning to a 'business as usual' approach for how we operate with COVID-19 in the community. ACHA's senior leadership teams, in conjunction with the Healthscope network, continued to guide our people to ensure the safety and protection of our patients, workforce, VMOs, contractors and visitors. They are to be congratulated for their outstanding work.

ACHA continued to support SA Health with their COVID-19 requirements, with our hospitals providing varying types of assistance to the Local Health Networks and SA Virtual Care Service.

One of the primary challenges in 2022 was workforce pressures due to COVID-19 employee furlough and cancelled operating lists. Our heartfelt thanks to all of our staff for their commitment, adaptability and flexibility in ensuring OneACHA provided quality patient centred care during this period.

Using the OneACHA approach in 2022, we implemented some innovative recruitment and training initiatives as well as targeted marketing campaigns to promote our specialties. A refresh for some of our branding was also undertaken to better reflect the connections between our hospitals and ACHA.

2022 saw some changes to our senior leadership team. Ms Janet Jongeneel was appointed the new General Manager at Flinders Private Hospital. Part of The Memorial Hospital family for the past 25 years, with the last six as the General Manager, Ms Jongeneel brings a genuine strength in building teams, staff culture and seeing team members progress in their careers.

We thank outgoing General Manager Ms McCabe for her contribution to developing and growing the ACHA business over the past 18 years.

Ms Sue Coe was appointed as the new General Manager at The Memorial Hospital in early 2023. Ms Coe has over 30 years' experience in managing acute and rehabilitation hospitals and is a firm advocate for patients and staff alike.

Each year ACHA and Healthscope seek to acknowledge staff who have excelled throughout the year and embody the Ace values of "We Care, We Strive, We Do, We're a Team". In 2022, ACHA's hospitals were well represented with five finalists from 31 individual or team nominations. We are very proud of the individuals and teams across OneACHA who were nominated and recognised for their outstanding contributions.

Looking forward, 2023 will see the completion of the \$20.3m staged upgrades across our Central Sterilising Supply Departments (CSSD). All three hospitals will be compliant with the new standards that now come into effect in December 2024. The new CSSDs will offer streamlined and integrated services for our hospitals.

Work Health Safety & Injury Management (WHS & IM)

The Work Health and Safety journey continued during 2022 with ACHA Health & Safety Representatives (HSRs) winning a national WHS competition for teamwork for a workshop they ran to improve their ability to influence safety culture and outcomes. The workshop focused on mental agility, resilience and psychological safety.

As 2022 commenced with a COVID-19 lock down, a major focus was staff well-being while the broader ACHA community contended with the ever changing environment at work and home. This initiative was supported by ACHA's Employee Assistance Program (EAP) provider, with programs focusing on a positive mindset during times of change.

The executive leadership interactions continued to grow over the reporting period and positively influenced workplace safety across all areas of our hospitals. The OneACHA approach was embraced by ACHA HSRs. The HSR Appreciation Day was once again a big hit with the guest speaker, a WHS specialist (and part-time snake catcher), encouraging staff to look more innovatively and laterally when solving WHS problems.

A snapshot of the year:

- Positive engagement with staff, VMOs, practice staff, patients and visitors on managing the COVID-19 risk through regular and targeted communication
- Over 340 safety leadership interactions by the executive teams – an improvement of 40% on the prior year
- A further 12% reduction in Lost Time Injury Frequency Rate following a 14% improvement in the prior year

Many thanks to the ACHA WHS & IM team for another positive year as we prepare for a RTWSA self-insurance evaluation in 2023. Special recognition to ACHA WHS Manager, Ms Sally Ralph who we farewelled in 2022. Ms Ralph was instrumental in developing the current ACHA WHS system and safety culture across ACHA.

ACHAIT

Resilience of systems and cyber security were the main focus areas for ACHA IT during 2022. To assist staff with more efficient communications across all sites we upgraded our mobile phone (DECT) system. Parallel to this work, upgrades were also made to the emergency paging system.

Within our CSSDs, an updated instrument tracking system, Precision Medicals' MaQS, was deployed. This allows for reusable theatre instruments to be logged and tracked throughout the hospital, from cleaning and sterilising, to being used in theatres. ACHA would be one of the first hospital groups in Australia to meet the AS/NZS 4187 requirements where instruments are traceable to the patient.

Additionally, within the MaQS system, pre-prepared instrument kits are available for VMOs, based on the type of surgery the VMO is undertaking. Our teams monitor demand for each procedure and prepare trays with the specific instruments used by individual VMOs.

Working with the clinical staff, the IT team deployed a Temperature and Humidity Monitoring System across all hospitals, providing real-time monitoring of medication fridges, theatre storerooms and other clinical areas. Staff have full visibility over the devices in their area via a web portal, with automated alerts being sent via email, push notification and SMS. Further rollouts are planned in 2023 to assist with monitoring temperature control for perishable drugs and vaccines.

Looking forward to 2023, planning is well underway for additional data pathways to further enhance fast access to information for our staff and VMOs.

ACHA proactively monitors and tests our systems to ensure we are fully compliant with all cyber security regulations.

Procurement

2022 demanded a relentless focus on security of supply. Continuing challenges resulting from the COVID-19 pandemic saw numerous interruptions within our supply chain both globally and domestically. Demand for PPE remained at historical highs, whereby multiple sourcing channels were developed to ensure our people, VMOs and patients have what is required to promote their safety. In addition, we were able to rapidly secure a reliable source for Rapid Antigen Tests to support our pandemic response.

Our ability to manage our supply chain and generate insights through the use of data has improved significantly over the last 12 months

In partnership with Healthscope, our *Source, Spend & Supply Better* strategy progressed during 2022.

- Source Better identify and strategically leverage economies of scale across consumables, capital equipment and key services to deliver sustainable value while working only with reputable partners who meet or exceed our high standards.
- Spend Better improvements in data quality and the modernisation of our purchase to pay processes.
- Supply Better design a fit-for-purpose end to end supply chain supported by digital inventory, delivering the most efficient material management processes from our vendors, to our theatres or wards. The right product of the right quality, in the right quantity, in the right place at the right time.

Every effort is made to ensure our supply chain partners adhere to the ethical and legal standards expected.

Under the requirements of the *Modern Slavery Act 2018* (Cth), ACHA lodges an annual Modern Slavery Statement with Australian Border Force.



Focus

Safety and Quality Systems

A primary focus for ACHA is maintaining our high standards of quality and safety.

Effective clinical governance recognises that the accountability for safe and effective patient centred care rests equally on everyone, from front line clinicians to managers, to the executive teams and the governing body.

ACHA is scheduled for our National Safety and Quality Healthcare Standards (NSQHS) Organisation-Wide Assessment for re-accreditation in June 2023.

Quality Improvement Initiatives

Our commitment to safety and quality ensures that ACHA is well placed with systems that have reached a healthy level of reliability and maturity. Patients, consumers and the broader community hold an expectation that health services and the clinicians working within them will provide a level of care which is safe and of high quality.

Improvement activities undertaken during 2022:

- Implementation of an electronic system to measure, analyse and report, auditing, KPIs and Clinical Indicators
- Implementation of an electronic Quality Management System (eQuaMS) to manage and monitor quality activities – 'Always Ready' initiative
- Updated patient safety information in real time, through the Data Analytic Service Hub (DASH)
- Establishment of an Indigenous Engagement Plan with Consumer consultation, review of 'Acknowledgment of Country' and development of an accompanying video presentation
- Ongoing implementation of resources for managing delirium and difficult behaviours
- Commenced the 'Better Discharge and Transfer of Care' project
- Implementation of the prevention and management of patient falls package and the implementation of resources for the prevention of sepsis
- Continued consumer representation on the ACHA Safety and Quality Committees
- Review of patient incident outcomes reporting as part of the risk management system

ACHA VMO Experience

VMO Experience remains a key focus across ACHA.

With a renewed emphasis on communication, our VMOs benefit from multiple platforms to assist them to stay up-to-date with key changes. We have continued to progress our OneACHA strategy and have further streamlined email communication to our VMOs and practice staff.

To better understand their experience and feedback, Nurse Unit Managers and other key staff regularly attend patient rounds with VMOs.

Our Continuing Professional Development program provides the GP community with education and networking opportunities for healthcare professionals and supports our VMOs in connecting with local GP referrers.

A number of OneACHA campaigns have marketed our cardiology and orthopaedic services to GPs and the community. These campaigns showcase the benefits of choosing an ACHA VMO at an ACHA hospital, as well as highlighting ACHA's leading facilities and technology. Targeted to prospective patients in addition to GPs, the digital campaigns use a mix of Facebook and Google Search advertising in our catchment and surrounds.

In November 2022, it was a great pleasure to see a VMO cricket match again after these were put on hold in prior years. Ashford Hospital hosted a team of doctors from Tata Memorial Centre, Mumbai, India for a friendly game of Twenty20 cricket. The Ashford Hospital team comprised a star line up of VMOs and colleagues and were the winners on the day. It was a hotly contested match, held in good spirits, with both teams demonstrating great passion for the game.

Our People - Nurses

ACHA's nurses are the mainstay of our hospitals. It is their dedication and clinical experience that underpins ACHA's reputation for providing excellent patient centred care.

Relationships matter in healthcare and to further improve on our already strong patient centred care focus, the Relationship Based Care (RBC) philosophy has been introduced to our staff.

Every interaction is a moment to make a difference. Using RBC, we can create positive experiences every day from our interactions with our patients and their families and with each other to enhance our relationships. The benefits include improvements in patient and staff satisfaction as well as safety and quality.

Recruitment and retention of our nurses is a major ongoing focus at ACHA.

With the continued impact of COVID-19 on recruitment, 2022 proved to be a challenging year for our nurses. While different avenues for recruitment have and continue to be explored, a change in focus was required to attract senior nurses in this environment. To recruit overseas candidates, we implemented a OneACHA approach which was developed through a leading international healthcare recruitment company.

Part of the campaign included a live recruitment webinar held in March 2022, hosted by the Directors of Nursing from our three hospitals showcasing ACHA and the South Australian lifestyle. This was attended online by 30 potential candidates from the UK, NZ and Singapore. The live webinar was recorded and is available to view on demand. This successful campaign has seen ACHA recruit a good number of senior staff.

Our robust Graduate Nurse Programs (GNP) also continues with a 'Grow your own' focus. For Flinders Private Hospital, 30 graduate nurses commenced in 2022 on permanent contracts, with a further 33 commencing at Ashford Hospital and 11 at The Memorial Hospital.

All ACHA hospitals also participated in the Healthscope National Introduction to Perioperative Nursing Practice Program which commenced in June 2022, allowing eight nurses to be fast tracked through the program over a 12 week period.

Flinders Private Hospital continued with the University Specialist Nursing program during 2022, where specialist student placements were offered training in Intensive Care, Cardiac Services and Peri-operative nursing.

Ongoing support was provided throughout 2022 for our nurses pursuing post graduate studies in intensive care, cardiac care, orthopaedic, paediatric, cardiac and stomal therapy specialties.

The 2022 Maxine and Bill Alver Scholarship at Ashford Hospital was awarded to Danielle Ronquillo, anaesthetic RN. The scholarship will be used to complete a Graduate Diploma in Nursing Science (Anaesthetics and Recovery Nursing).





Our People

Ms Lynley-Ann Dodd, an anaesthetic nurse in the angio suite at Flinders Private Hospital competed in the Commonwealth Games in the UK during August 2022 in a new esports non-medalled event. It was introduced into the Games as a demonstration for its future inclusion as a medal event in 2026. Esports, an abbreviation of electronic sports, is a form of competition using video games, often taking the form of organised, multiplayer video game competitions, either individually or as teams.

Ms Dodd and four other women represented Australia and played against competitors from multiple countries. The Australian women's team finished 4th. The event was covered by ABC Sports, the Daily Telegraph and was broadcasted on the BBC in the UK, as well as online for international viewers.

Ms Dodd commented that "this is something we never imagined we'd have the opportunity to do, and this event will determine the future direction of esports. As women we are underrepresented in many professional esports tournaments and as a team, it is an amazing opportunity and a privilege to participate in a worldwide event, not only representing our country, but our fellow female gamers."

An 'Ace' year at Ashford for Adele

Ms Adele Shaw, a highly respected physiotherapist at Ashford Hospital for over 12 years, was the winner of the ACHA / Healthscope Ace Award 'We Strive' – Individual category in May 2022.

Ms Shaw was instrumental in the establishment of a physiotherapy student program which was launched at Ashford Hospital in collaboration with Flinders University, in 2021.

The program provides supportive hospital placement for undergraduate physiotherapy students. This has resulted in increased interest from students applying to work in acute private hospitals such as Ashford Hospital, following the completion of their university studies.

Ms Shaw was also recognised by the university, as the recipient of the Flinders University Physiotherapy Excellence in Placement Supervision Award for 2022.

Feedback from students has highlighted the excellent environment created by Ms Shaw for learning that makes students want to succeed in this often-challenging environment. She was encouraging while supporting students to maintain a high standard of supervision and clinical care.

In January 2022, the \$1.3m project to install a new Siemens Artis Q-floor imaging unit into Cath Lab 2 of the Ashford Hospital Angiography suite was completed. During the six week period when Cath Lab 2 was out of action, VMOs and staff continued to provide exceptional service while operating out of Cath Lab 1.

This new unit ensures the highest quality imaging is available for our patients and provides our cardiologists with access to state-of-the-art technology. An upgrade to the scrub room was also undertaken at the same time.

During 2022 the Staff Events and Wellbeing Calendar for Ashford Hospital focused on staff appreciation, with traditional staff engagement events from previous years being reshaped with an emphasis on appreciation and inclusion, acknowledging the hard work and contribution of our teams, including:

This was a personal and impactful patient story of his bowel cancer diagnosis and subsequent treatment. Zak's message was incredibly important. His story was told via the Ashford Hospital Facebook page and YouTube through a video series.

The series also featured ACHA VMO, Prof Peter Hewett, Colorectal Surgeon, urging the community not to ignore the symptoms. Prof Hewett said, "It's very common for people under the age of 50 to dismiss their symptoms ... without going to see a health professional to get proper investigations."

Also, throughout that month, the team at Marleston Ward, one of Ashford Hospital's surgical wards, organised a series of bowel cancer events. They raised over \$1,000 for Bowel Cancer Australia by selling bowel cancer awareness ribbons, providing apples for patients and staff on Red Apple Day and hosting a fundraising bake sale.

2022 has been a year where we continued to look forward and build on strong foundations and commitment to our purpose, values and goals. Our commitment has underpinned the innovation and flexibility required to adopt the right changes necessary to meet the challenges of a waning pandemic environment.

Flinders Private Hospital is unique in SA due to its co-location with Flinders Medical Centre and has a long standing relationship with Southern Adelaide Local Health Network (SALHN). We continued to work closely with SA Health, SALHN, VMOs, staff and our patients to deliver a safe and connected response to the growing demand for healthcare in our community.

At Flinders Private Hospital we continue to invest and expand services for our patients. A refurbishment of the CSSD commenced in February 2023. Expected to be completed within four months, the project includes construction and the procurement of new sterilisers and washers, as well as increasing our fleet of instrumentation and equipment.

During this period, all sterilising of instrumentation will be undertaken at the newly completed and expanded Ashford Hospital CSSD, Flinders Private Hospital CSSD staff will work across both sites to maintain business continuity. The investment in the new equipment in the upgraded CSSD will provide for growth in surgical specialties and VMO support.

The installation of a new space saving shelving system for the Angiography Suite occurred in October 2022. The system provides a colour coded systematic storage solution for sterile stock. Ergonomically, the shelving is easier to move and the angled baskets provide easy access. Other benefits include greater time efficiency and clearing valuable floor space required for the new CSSD upgrade on the ground floor.

To provide greater access to Magnetic Resonance Imaging (MRI) services for patients at Flinders Private Hospital and the southern suburbs, Radiology SA now has a MRI at the hospital. This technology will provide a greater level of service for our orthopaedic, oncology, neurosurgery and cardiology patients.

Mr Dean Rowe, a Flinders Private Hospital Consumer Representative has a long connection with the hospital - he and his late wife Judith have been former patients.

At 89, Mr Rowe also works tirelessly to fundraise for the Cancer Council and Judith's Legacy to increase awareness and support for those affected by ovarian cancer. As well as the annual Judith's Walk along the Shiraz Wine trail, Mr Rowe organises many other fundraising events. Initially aiming for \$60,000, he has now raised over \$84,000 towards the new target of \$100,000.

Our thanks to everyone who has supported Mr Rowe and Judith's legacy.

Investing in our future

Amongst others, orthopaedic surgery is a key speciality of The Memorial Hospital. To support this, two orthopaedic robotic surgical systems, a Stryker Mako™ Robotic-Arm Assisted Orthopaedic Surgery System and a Zimmer Biomet ROSA® Knee System, were acquired in 2022.

The ROSA, which stands for Robotic Surgical Assistant, is used for patients undergoing knee surgery. The robotic technology is designed to work with individual patient anatomy. Specially trained VMOs use this to tailor the placement of the knee implant specific to each patient.

The Mako is also used by specially trained and credentialed VMOs for both partial and total knee replacements as well as total hip replacements. The Mako uses 3D CT-based planning, haptic technology and real time data analytics in one platform. This allows for the creation of surgical plans specific to each patient as well as the ability for VMOs to refine the surgical plan intraoperatively for the best outcome.

These investments assist The Memorial Hospital in being a leader in providing the latest technology for our VMOs and patients.
